GROUP CONTRACT: TERMS & CONDITIONS

- Please ensure your entire party arrives 15 minutes prior to the scheduled appointments to allow time to check in and so everyone can start on time. Late arrivals will result in the adjustment of appointments, downgrading of services or cancellations of appointments to keep the providers runnings on schedule.
- We recommend that you book your appointments as far out as possible in order to guarantee availability on the day and time that works best for your group. Please assign one person to be the coordinator for your group. A signed and completed group contract is needed before the holding of any spots or booking of appointments.
- Late Additions or changes to services will be considered, but cannot be guaranteed once the appointment schedule has been filled due to limited space and time constraints.
- Apparel: Come as you are, depending on your services and activities before or after your time with us. Recommend comfy clothes, or items you can change in and out of easily if you are having massages and/or facials. When getting pedis, please wear bottoms that can easily be rolled up. Feel free to bring your own open toed-shoes - disposable foam ones will be provided, if you forget.
- We do not allow outside alcohol in the building. We have complimentary wine and champagne on site that can be provided to anyone over 21, depending on the services - limit two per person per visit. Outside food and non-alcoholic beverages are allowed.
- Please be respectful of others in the spa and keep noise and cell phone use to acceptable levels. If all or part of your party must be removed from the building for disturbances and cannot complete their scheduled services, there will be no refund.
- Feel free to use the showers and lockers room in the spa. Anthony John's is not responsible for personal property if it is lost, though we will try our best to return items that are found.
